Instructions on Citation & Style

I. Notes

1. The names of author(s) shall be typed under the title of the article in Chinese and English respectively; affiliation and education shall be presented in the footnote without series number.
2. Quotations, sources, and explanatory texts shall be cited in footnotes. Common Era (A.D.) shall be used for specifying a year. Notes cited in secondary sources shall be specified.
3. Notes shall be on the same page with the text, i.e. footnotes.

(1) Chinese and Japanese literature

When citing the immediately preceding note, use 「同前註，第○頁」；when citing several preceding notes, use 「作者，同前註，第○頁」；when citing several preceding notes from the same author, use 「作者，文獻名稱，同前註，第○頁」。If there are other notes in between, the author, publication title, and publication information should be completely cited again.

(2) English literature

When citing the immediately preceding note on the same page, use “*id.* at ○(page)”.

(3) German literature

When citing the immediately preceding note on the same page, use “*Ebd.*, S. xx (page) or Rn. xx (paragraph)”.

4. The year, page numbers, issues and volumes, and legal provisions in Chinese and other languages are written in Arabic numerals. When citing foreign statutes and court decisions, follow usual citation style of that country. Collected papers shall be specified with 「」; Constitutional interpretations from Grand Justices, legal provisions, and administrative orders shall be specified without giving dates and references.

5. Examples of notes are as follows:

(1) Books, Book Chapters, and Journal Articles in Chinese:

A. Books

Format: Author, Book title, Publisher, Date, Edition (Except the first edition, the edition of the books shall be specified), Pages.

Example: 黃俊杰，行政法，三民書局，2019年3月，5版，第74頁。

B. Book Chapters

Format: Author, Book chapter title, Editor(s), Book title, Date, Pages.

Example: 林德瑞，我國智慧財產權受侵害之損害與懲罰性賠償，收錄於劉春堂教授六秩華誕祝壽論文集編輯委員會（編），「民事法學新思維之開展」，2008年5月，第273頁。

C. Journal Articles

Format: Author, Article title, Journal title, Volume and issue, Date, Pages.

Example: 陳文吟, 由美國實務經驗探討基礎科學專利對生物科技的影響, 台北大學法學論叢, 第 67 期, 2008 年 9 月, 第 115 頁。

(2) Books, Book Chapters, and Journal Articles in Japanese:

Books: 大村敦志, 消費者法, 有斐閣, 2011 年 4 月, 4 版, 第 13 頁。

Book Chapters: 內田貴, 民法 IV 補訂版 親族・相続, 東京大學出版會, 2009 年 2 月, 第 285-286 頁。

Journal Articles: 潮見佳男, 投資取引と民法理論(四), 民商法雜誌, 第 118 卷第 3 期, 1997 年 6 月, 第 10 頁。

(3) Books, Book Chapters, and Journal Articles in English:

A. Books

Format: Author (small capitals), Book title (small capitals), Pages (Publisher, Edition, Date).

Example: STEPHEN M. BAINBRIDGE, CORPORATION LAW AND ECONOMICS 321 (Foundation Press, 2002).

B. Book Chapters

Format: Author, Title (*italic*), in Book title (small capitals) the first page of the book chapter, the cited page(s) (Editor, Publisher, Date).

Example: Bradford P. Wilson, *Separation of Powers and Judicial Review*, in SEPARATION OF POWERS AND GOOD GOVERNMENT 62, 82 (Bradford P. Wilson & Peter W. Schramm

eds., 1994).

C. Journal Articles

Format: Author, Title (*italic*), Volume and issue (small capitals), the first page of the journal article, the cited page(s) (Date).

Example: John Kay, *The Economics of Intellectual Property Rights*, 13 INT'L REV. L. & ECON. 337, 340 (1993).

(4) Books, Book Chapters, and Journal Articles in German:

Books: Peltzer, *Deutsche Corporate Governance*, 2. Aufl. 2004, S. 102. (The number of a paragraph should be presented by "Rn. 102".)

Book Chapters: Bernd Schulte, *Alterssicherung im Vereinigten Königreich*, in: Hans-Joachim Rheinhard (Hrsg.), *Demographischer Wandel und Alterssicherung*, 2001, S. 295-297.

Kommentar: Werner Neumann, in: Stelkens/Bonk/Sachs (Hrsg.), *Verwaltungsverfahrensgesetz*, 8. Aufl., 2014, § 72, Rn.73.

Journal Articles: Klaus Schreiber, *Das Arbeitsverhältnis beim Übergang des Betriebs*, RdA 1982, S. 137 ff.

(5) Books, Book Chapters, and Journal Articles in French:

Books: CHAUCHARD (J.-P.), *Droit de la Sécurité sociale*, LGDJ, 2007, p. 25.

Book Chapters: PAUCHARD (P.), *Droit de Protection sociale*, in: DUPEYROUX (J.-J.), *Droit de la Sécurité sociale*, 2006, p. 66.

Journal Articles: EUZEBY (A.), *Protection sociale dans la déclaration et pactes international*, Dr. soc., 2007, n° 2, p. 11.

(6) Translated works:

Format: Author (translator), Book title, Edition, Publisher, Date, Pages.

Example: 亞圖·考夫曼著（吳從周譯），類推與事物本質--兼論類型理論，學林文化事業有限公司，1999年11月，第25頁。

(7) Theses:

Format: Author, Title, Graduated University, Date, Pages.

Example: 盛子龍，行政法上不確定法律概念具體化之司法審查密度，國立臺灣大學法律學研究所博士論文，1998年6月，第18頁。

(8) Conference proceedings:

Format: Author, Title, Conference name, Conference organizer, Venue, Date.

Example: 曾品傑，臺灣法上債之地位移轉，第七屆東亞民法國際學術大會，日本京都大學主辦，日本京都，2017年12月。

(9) Research reports:

Format: Project director, Title of the project, Sponsor, Date, Pages.

Example: 王志誠，銀行業在長期照護產業鏈之角色定位及業務創新，中華民國銀行商業同業公會全國聯合會，2016年7月，第12頁。

(10) Electronic databases:

Format: Author (small capitals), Book title (small capitals) paragraphs or pages (database updated date).

The example: Mark S. Lee, Entertainment and Intellectual Property Law § 9:3 (Westlaw database updated Aug. 2020).

- (11) Constitutional interpretation from Grand Justices: 司法院釋字第 813 號解釋
- (12) Legal provisions: 企業併購法第 4 條第 3 款。
- (13) Administrative orders: 內政部(75)台內勞字第 415571 號函。
- (14) Judgments: 最高法院 110 年度台上字第 182 號民事／刑事判決。
- (15) English judgments: *Miranda v. Arizona*, 384 U.S. 436 (1996).
- (16) Court resolutions: 最高法院 107 年度第 8 次民事庭會議決議，民國 107 年 9 月 25 日(09/25/2018)。
- (17) News:

Format: Author, Title of the article, Source, Edition, Date.

Example: 張金鶚，住房價格與品質省思，聯合報，A10，民國 111 年 2 月 7 日(02/07/2022)。

- (18) Website sources:

Format: Name of author or agency, Title, Source, Date, Website (accessed date).

Examples:

Chinese articles: 賴英照，〈獨董開股東會…〉，經濟日報，民國 111 年 1 月 26 日(01/26/2022)，https://money.udn.com/money/story/5629/6060819?from=edn_course_index (最後瀏覽日：01/27/2022)。

English articles: Mike Thomas, The Future of AI: How Artificial Intelligence Will Change the World, (12/01/2021), *available at* <https://builtin.com/artificial-intelligence/artificial>

-intelligence-future (last visited on 01/17/2022).

II. References

1. For the coordination of the style, authors are required to list the references at the end of articles to facilitate readers' consultation. Authors should translate Chinese references into English citation styles and indicate the start and ending pages of Chinese and Japanese books and journal articles. For books and journal articles in other foreign languages, follow the usual citation style of that country to specify the beginning page.
2. Bibliography should firstly list references in Chinese and Japanese and is followed by references in other foreign languages. References in Chinese and other foreign languages are listed in the order of the number of strokes of Chinese family names or in the alphabetical order of English Family names. Common Era (A.D.) shall be used for specifying a year. Examples of references are as follows.
3. Chinese and Japanese references:
 - (1) Books:

Format: Author, Book title, Publisher, Date, Edition (Except the first edition, the edition of the books shall be specified).

Examples: 王志誠，現代金融法，新學林出版公司，2009年10月，3版。

WANG CHIH-CHENG, MODERN FINANCIAL LAW (New Sharing Publisher, 3rd ed., 2017).

江頭憲治郎，株式會社法，有斐閣，2008年10月，2版。

(2) Book Chapters:

Format: Author, Title, Editor, Book title, Publisher, Date, Pages.

Examples: 林德瑞，股份有限公司股東對公司會計表冊之閱覽權，收錄於賴源河編，「商事法實例問題分析」，五南圖書出版公司，2000年12月，第125-141頁。

(3) Journal Articles:

Format: Author, Article title, Journal title, Volume and issue, Date, Pages.

Examples: 王文宇，金融控股公司法制之研究，國立臺灣大學法學論叢，第30卷第3期，2001年5月，第49-184頁。

WANG Wen-Yu, *Study on Law of Financial Holding Company*, 30(3) NATIONAL TAIWAN UNIVERSITY LAW JOURNAL, 49-184 (2001).

4. Other foreign references:

- (1) All references presented in articles and citations should be listed and arranged in the alphabetical order of English family names. Family names should be firstly presented and are followed by first names. Multiple references from the same

author shall be arranged by the publication years.

Examples:

A. Books:

Format: Author (small capitals), Book title (small capitals)
(Publisher, Edition, Year).

Examples: COOTER, ROBERT & ULEN, THOMAS, LAW &
ECONOMICS (Addison-Wesley, 6th ed., 2012).

Eisenhardt, Gesellschaftrecht, 11. Aufl. 2003.

B. Book Chapters:

Format: Author, Book chapter title (*italic*), in book title (small
capitals) Pages (Editor(s), Publisher, Year).

Example: Bradford P. Wilson, *Separation of Powers and
Judicial Review*, in SEPARATION OF POWERS AND GOOD
GOVERNMENT 62 (Bradford P. Wilson & Peter W. Schramm
eds., 1994).

C. Journal Articles:

Format: Author, Article title (*italic*), Volume and issue (small
capitals) Pages (Year).

Examples: Corbete, Ronalds J. T, *Protecting and Enforcing
Intellectual Property Rights in Developing Countries*, 35 INT'L
LAW. 1083 (2001).
